



**Irrigation Association of New York
Scholarship Requirements**

1. Every applicant must be a dependent (child/grandchild) of an IANY member-company employee.
2. A sponsor company must be an active member of IANY for a minimum of two years.
3. A member may sponsor only one applicant per year.
4. A sponsor must write a letter of recommendation on behalf of the applicant.
5. Applicant must provide verification of enrollment from the college or university for this year such as verification from the bursar's office.
6. Graduate students are eligible for a scholarship.
7. An individual may receive up to four scholarships from IANY. It does not matter if the scholarship is for undergraduate or graduate school; the maximum he/she may receive is four.
8. Applicants are eligible for a scholarship in consecutive years.
9. Applicants must be enrolled on a full-time basis with a minimum curriculum of 12 credits per semester.
10. Applicants will be required to completely fill out a scholarship application form provided by the Scholarship & Research Committee.
11. All above requirements must be met for applicant to be considered.
12. Incomplete applications or applications received after the deadline will not be considered for a scholarship award.
